Membership

The Angus Tourism Cooperative (ATC) is a not for profit consortium cooperative, which is a democratic membership organisation. It is a company limited by guarantee, with each participating business becoming a member of the company and each member having an equal say in how the consortium is run.

- Membership is open to individuals or bodies involved in the tourism sector in Angus.
- Associate Membership is open to individuals or bodies that support, or are engaged in business complementary to, the tourism sector in Angus.

Membership Fee

- The annual membership fee is £25, for both full and associate membership.
- The fee is payable in April of each year.

N.B. The fund from membership fees will allow the group to apply to various funding sources including VisitScotland's Growth fund.
